THE BEST ADVICE FOR ACADEMICS

Students, as you enter the home stretch of another school year,

pray that you finish this year strong. As the weather gets warmer and the year seems to have gone on forever, it can be tempting to let up or slow up, and coast on in. Don't fall into that trap.

I'm going to give you (and your parents and grandparents) the greatest piece of academic advice that I've ever heard. Incorporating this advice into your life can make all the difference, not just with your grades, but in your job performance and successes afterwards.

It comes from my motherinlaw, but it was also employed in my home growing up. My wife often told the story of the classic struggle of school work over the weekend. Invariably, the paper or the test study gets put off until Sundays, and the temptation was to use that as an excuse to stay home from church. The reasons was that "school work" is important.

But that never flew... her parents (and mine) would have none of that. They were preparing their children to succeed in life, and school was just one part of that process. Consistency in values and an understanding of Who was most important in their home was also a part of that strategy. Her parents would refer to 1 Samuel 2:30, where the Lord said "...But I will honor those who honor me, and I will despise those who think lightly of me." That's the Message Version, but you get the point.

If you put your schoolwork ahead of God and think lightly of Him, that will not have Him on your side when the time of the test or the paper comes.... and honestly, if I want ANYONE on my side at that point, it's the Lord.

Proverbs 21:2 which reminds us of our own "endless capacity to justify" our actions, but how God is never fooled for a millisecond by things that we even try to fool ourselves with. It's not the schoolwork that nudges God out really. It's the activities on the rest of the weekend that we are actually putting ahead of God. We just find it easier to justify if we say it's "school work".

For us, our grades never suffered because we had to cut out something else, but instead this philosophy helped us, and the lessons from that principle in our home are still teaching us and our own children long after we've forgotten what grade we made in Calculus.

Establish a system in your life that honors God and if if there is a system that always seems to leave you with seemingly the "only" choice is to dishonor Him, junk it or put Him first regardless. In the end, you'll never be disappointed. To succeed at anything, especially academics, we must cultivate the ability to recognize the proper order of priorities and demonstrate the an unwaverina integrity to stay with that order ... even when it means you might need to lose some sleep to finish a paper because you honored the Lord a few hours earlier.

Dear Friends,

Twenty-seven years ago I moved to Brevard County after

completing 38 years of military service. In 1993 I became involved with the Alzheimer's Association of East Central Florida Chapter. During the course of my work with those suffering from dementia, I realized there were many other wonderful services in the county that remained a well-kept secret. In order to inform, educate, and connect seniors and those who care for them to the services they need to remain independent, Helping Seniors of Brevard, Inc. was formed in 2011.

At that time, the primary provider of information was 211 Brevard. Their mission is similar to ours but does not develop the same type of in-depth help targeted to elders. Other community assistance programs include Aging Matters, which provides services such as Meals on Wheels, and the Brevard Alzheimer's Foundation, which offers adult day health care and respite to those suffering from dementia. I could mention several others but suffice it to say that we have many outstanding service providers. However, we still lack the capability to inform Brevard residents – now more than half a million people – about these services.

For instance, it is one thing to say that we have a Veterans



Affairs Office. Does that tell us what they can do for Brevard's 70,000 veterans or the many widows of veterans who live on minimal incomes? While speaking to groups of retirees, I have discovered women living on \$600-\$800 a month who are the surviving, non-remarried spouses of World War II, Korean War and Vietnam War. This makes them eligible for financial assistance greater than what they were currently receiving. Yet they have no knowledge of these benefits. This is our job ~to educate and inform.

We have directories, speakers, pamphlets, health fairs, etc., but somehow the message is not getting through about the benefits that can be accessed through SHINE, the VA, One Senior Place, and other resources. Too often, we call a number and get another number to call, or just leave a message, or simply wait and never get an answer.

At Helping Seniors, our Information Specialist carefully to callers and gets them to the best source of assistance. Often the real problem is not the first stated, rather it is what is uncovered through what I call the listening process. Every call to Helping Seniors is logged and the calls not immediately answered are returned by the end of that working day.


In addition, Helping Seniors has a media outreach program that highlights an array of services and benefits available to all in Brevard. Our articles appear regularly in Senior Scene and Spotlight Magazines, Hometown News, Ebony News Today, and AL Dia Today, with an eight-page newsletter appearing each month in the center section of Senior Scene Magazine. Our television shows air at dedicated times on Bright House channel 199 and Space Coast Government TV channel 499, while our radio show is broadcast each Thursday at 1 PM on WMEL 1060 AM.

All these outlets feature programs that can help people in Brevard County. Information and education enable us to connect with sources of help for each other and for ourselves. No one can be forced to call about a needed service but it seems terrible to know about a way to help someone in need and not be able to tell them about it. 
What a Girl Wants/In Her Shoes takes place on Thursday April 28th at the Melbourne Auditorium from 5-9 pm.







REALLY... I PROMISE





HOW SAFE IS AIRPLANE WI-FI? SPOTLIGHT ON COMPUTING

When you're considering the use of any

public Wi-Fi service, two primary concerns are how secure the connection is and what limitations are imposed.

In-flight Wi-Fi has the same security concerns as a typical public connection found at coffee shops and hotels: If everyone uses the same password or there's no password required, then there's nothing separating users from each other.

Airline Internet service providers also use more controls on the connection so they can control what you can and can't do. Things like streaming video or using VOIP services like Skype are blocked to limit data usage because the overall shared bandwidth is pretty limited.

Without getting too deep into the technical aspects of the connection, it's important to understand that encryption of your data as it 'flies' over the wireless network is what keeps your personal information private. If you don't see https: at the beginning of the web address, then anything you type is going over the wireless network in plain text, which potentially can be viewable by others.

Even when you do see https:, because of the way that providers like GoGo Wireless manage the network, your information may not be as secure as

you think as detailed in this ARS Technica article (https://goo.gl/CiG3Tv) or from this USA Today reporter (http://goo. gl/48PsMk).

Another thing that I see just about any time I connect to public Wi-Fi are lots of computers that are sharing folders with others on the network. They're usually default share folders that probably don't contain anything of value since the user probably doesn't even know that they exist, but I've seen folders that were clearly created to share files with coworkers.





If you work in groups on the road and share things with each other, those shared folders will suddenly become available to anyone else on public Wi-Fi if you haven't properly secured them.

The best way to stay safe on any network that you don't completely control is through the use of a Virtual Private Network (VPN). A VPN creates a private network within a public network so everything that you type is securely protected from anyone else on the same network. There are a large number of free and pay options available that are pretty easy to set up and use.

Free VPN programs typically come in two flavors -- free but ad supported and free but limited in use. Two of the offerings that I like for non-technical users include CyberGhost (https://cyberghostvpn.com) and Private Tunnel (https://privatetunnel. com).

CyberGhost's free option requires you to view an ad for at least 17 seconds and shows ads every two hours with a 3-hour limit per session. You can pay for an adfree unrestricted account that's much faster for @\$7 a month if you travel often.

If you're not on the road as often, check out Private Tunnel's pay as you go offering. They'll provide the first 500MBs for free so you can try it out and then you pre-pay for data packages that never expire, so you don't have to commit to a monthly plan.

Fighting Glaucoma

Laser procedure can eliminate or reduce the need for costly medication.

hen computer programmer Kevin Gray needed a new pair of glasses, he got more than an updated prescription when he visited an optometrist. A routine exam revealed elevated pressure within his eyes. It was the first clue that he might have glaucoma, an eye disease that can cause irreversible vision loss if left untreated.

The optometrist referred Kevin to glaucoma specialist James N. McManus, MD, at The Eye Institute for Medicine & Surgery. plasty, or SLT, a brief laser procedure After more testing, Dr. McManus confirmed Kevin had developed glaucoma and needed treatment to preserve his sight. "I wasn't having any other symptoms," Kevin recalls. "My grandmother had glaucoma, so I guess I've got the precursor for it."

A symptom of glaucoma is increased intraocular pressure that damages the optic nerve over time. It is caused by poor drainage of the fluid that nourishes the eve's lens and cornea. The back-up of fluid increases pressure within the eye. Only in rare cases can patients feel this buildup of pressure.

Kevin was prescribed eye drops that control glaucoma by reducing eye pressure. His instructions were to place a single drop daily in each eye, a regimen

he faithfully followed for seven years. The eye drop therapy kept his glaucoma in check but became increasingly expensive. He was paying about \$100 every month for his prescription when he decided to look for another answer. "The eye drops were cost prohibitive," says Kevin.

Recently, he underwent an in-office procedure at The Eye Institute for Medicine & Surgery that made it possible to throw away the eye drops. The treatment is selective laser trabeculodesigned to increase fluid drainage inside the eye. SLT gently applies laser energy to the eye's drainage tissue, a tiny, spongy area called the trabecular meshwork. The result is better fluid drainage and therefore less pressure

"I didn't feel any discomfort at all. It seemed similar to one of my routine eye exams," notes Kevin about having the procedure. "First, they applied some fluid to numb the eye. In all, it took less than five minutes. I had the first eye done, and the other eye was treated a week later."

Impressive Results

A recent chart study at The Eye Institute for Medicine & Surgery indicates that SLT can be an effective alternative to glaucoma medications and eye drops.

For the retrospective study, Dr. McManus reviewed more than 100 charts of his patients who have undergone SLT. "The results were very impressive," he reports. "Seventy-five of the hundred patients in the study either eliminated the need for their glaucoma medications or reduced the number of medications they needed to take on a daily basis."

Sixty-two of those patients were able to stop their glaucoma medications entirely. That is good news for many reasons, adds Dr. McManus, When SLT eliminates or reduces the need for daily eye drop therapy, patients who previously weren't taking glaucoma medications as directed or skipping doses be-

cause of cost will no longer be risking vision loss. The latest generation of glaucoma medications is highly effective but requires the patient to be vigilant about compliance, notes Dr. McManus. Ignoring directions can, over time, lead to vision loss, even when a physician is following the patient.

Some patients may be non-compliant because of physical limitations. For example, they can't place drops correctly in the eye because of tremors due to Parkinson's disease or other neurologic disorders. Having a condition like rheumatoid arthritis can present challenges with even opening the medication bottle. Busy lifestyles can interfere with daily eye drop therapy, too.

"Many patients simply have numerous responsibilities and are always on the go. This is often why they forget to use their glaucoma medications every day," says Dr. McManus.

The high cost of glaucoma medications is another obstacle for many patients, he adds. When patients find the medications to be cost prohibitive, studies have shown many will skip doses to make their supply of drops last longer. "It's understandable when patients feel that they can't afford their medication. But they are risking their vision. If vision loss occurs, it is frequently permanent," warns Dr. McManus. The chart study at The Eye Institute for Medicine & Surgery also examined the potential financial impact on the US health care system when SLT eliminates the need for expensive eye drops to treat glaucoma.

Using life expectancy tables from the Social Security Administration, Dr. McManus and his team completed a cost analysis. Their conclusion: On average, when a patient no longer needs typical glaucoma medications, expected savings can be in excess of \$16,000 over his or her lifetime after being treated with SLT.

New Glaucoma Surgery


A new surgery for glaucoma is now avail- able at The Eye Institute for Medicine & Surgery. Using a new device called the Kahook Dual Blade, glaucoma specialist Jason K. Darlington, MD, is able to improve fluid drainage inside the eye to lower intraocular pressure and preserve the health of the optic nerve. The outpatient procedure is minimally invasive and takes less than 15 minutes.

"I can easily perform the surgery through a micro-incision, which is what makes it minimally invasive," assures Dr. Darlington.

"This is a very good procedure for patients who have a diagnosis of glaucoma and are undergoing cataract surgery. It can be done at the same time," he adds. "Afterward, they are likely to need less glaucoma medication or be off their medication entirely."

The Kahook procedure is also an alternative for glaucoma patients who have developed allergies to eye drops for glaucoma or aren't responding adequately to medications.

"If someone has tried all the medicated drops available and they haven't responded, instead of having a more invasive surgery, this minimally invasive procedure can be done first," says Dr. Darlington. "It can be a safe, alternative way to control glaucoma."







Have you ever stood in front of a microwave oven, thinking,

I also know perfectly well that God works to my eventual good, so that whatever happens will end up being the best possible thing that could've happened to me, no matter how bleak things may seem to me right now.

If you are an impatient person as I used to be, I urge you to reflect on these things, and read about them in God's Word. How carefree and happy you will be to discover true liberty in the Lord.




